*Note on item 12:* 

At its meeting on 18 April 2016 the Warwick District Standards Committee considered a report on a future Joint Standards Committee, which effectively would mean continuing the existing arrangements for dealing with complaints against Councillors: the Parish Council agreed to continue the current Code at its meeting on

13 July 2015 (item 1663). Accordingly, all participating Councils are asked to adopt the resolution at item 12 on the agenda above.

As a matter of information, in the event of a Parish Council's not wishing to join the Joint Committee any complaint about the conduct of one of its Councillors would still be considered by Warwick District Council, as required by the Localism Act 2011, under its adopted process; if the matter progressed to a Hearing Panel this would be considered by Warwick District Councillors only and any outcome from the Hearing would be recommended to the relevant Council for it act upon.
