# OLD MILVERTON AND BLACKDOWN JOINT PARISH COUNCIL MINUTES OF THE MEETING HELD ON MONDAY 4TH. JULY 2022, 8.00 P.M., AT OLD MILVERTON VILLAGE HALL 

PRESENT: Councillors J. Emmerson (in the Chair), Mrs. L. Keeling and W. M. O. Tansey; County and District Councillor W.I.Gifford; and District Councillor Caroline Gifford.

APOLOGIES FOR ABSENCE: Apologies for absence were received from Parish Councillors Rachel Pope and M. Rayner; County and District Councillor Redford; and District Councillor S. Syston.

MINUTES OF PREVIOUS MEETING: Subject to deleting "Feasibility for Blackdown Roundabout - Old Milverton Footpath within the heading Grass Verge" within Appendix A the phrase "Cllr. Emmerson had instructed Sustains of Bristol" to read "Cllr. Emmerson was considering approaches to Sustains of Bristol" the minutes of the meeting on 16th. May 2022 were approved, and signed by the Chairman.

## MATTERS ARISING FROM PREVIOUS MEETING

(a). Details were still awaited concerning traffic speeding and counting, but it was recognised that this was included in a list of Countywide commitments.
(b). Notification had been received that the Forestry Administrator of Warwickshire County Council that underground services might have to limit the planting sites of trees on Stoneleigh Road, Blackdown. The Tree Officer would like to consider planting large longer-lived trees, not necessarily native to the area and was due to make suggestions of the species with costs, whereupon, the Parish Councillor might part-fund the planting.
(c). The conditions of footpaths within the verges of Stoneleigh Road could be regarded as dangerous since the paths had been cut back to their original widths and the Clerk was asked to pursue the Highways Engineer about proposals to make them safe.

## CIL FUNDED PROJECTS

Account was taken of selected projects to be funded from CIL income. Already received was $£ 7,130.00$ in respect of Blackdown House, Old Milverton lane and $£ 7,500$ in respect of Jephson House (now known as Jephson Court), Stoneleigh Road, and 5,700 was likely later in the financial year, by which time new dwellings at Jephson Court might have become available, which would increase the sum to be paid.

The projects under consideration were:
(a). Two "Welcome to Blackdown "signs on Stoneleigh Road, Blackdown. It was agreed that the siting of the sign leaving Bericote Roundabout was satisfactory but that the sign nearer Blackdown Roundabout should be be sited half way between Blackdown Roundabout and the enhance to Jephson Court.
(b). Provision for a bench on the green area at the junction of Stoneleigh Road and Bericote Road. It was hoped to limit expenditure to about $£ 650.00$ plus fixing.
(c). Installation of illustrated footpath sign boards. Councillor Pope had suggested the provision of eight boards - four in Old Milverton and four in Blackdown - but the cost was expected to be significant and it might be necessary to cut down on the numbers of signs in the first instance.
(d). Feasibility study into the provision of a footpath in the grass verge on Old Milverton Lane between Blackdown Roundabout and Old Milverton Village. Demands of the other project s might cause in this item to remain incomplete.

The Clerk was asked to circulate summaries of the projects with a view to conducting an "e-mail exchange" of views on how to proceed initially.

## REVIEW OF RECENT PLANNING APPLICATIONS

(a). No response had yet been received from the Enforcement Team in respect of the Parish Council's concerns about development at Quarry Bank, Old Milverton Lane, but a new Planning Enforcement Officer had been appointed charged with going through the backlog of cases, so it was hoped that information might be received shortly. Meanwhile, Ridge Consultants had been asked to contact the District Council with a view to identifying the problems.
