- (b) Electric Scooters had been observed in use in the parishes, agreed to put posters on notice boards reminding people that use on the public highway or footpath is not lawful
- (c) Cllr Redford informed the meeting of the use of Electric Buses with a range of 280 miles. Also that average speed cameras were on trial in 4 sites, this prompted discussion on the parish councils request for traffic monitoring, information to be re-sent to Cllr Redford and the parish council agreed to fund the 4 sites in Old Milverton and Blackdown previously mooted at a cost of £500 per site
- (d) Cllr Redford informed that the HS2 project would fund £106,000 per annum (until 2025) for maintaining routes used by their haulage lorries
