## **Strategic Growth Location 06**

The green belt north of Leamington has been designated a strategic growth location in the *Preferred Options Consultation* for the South Warwickshire Local Plan (SWLP).

In total, there are 24 strategic growth locations and 12 new settlement locations across South Warwickshire. They are all possibilities and none have been decided upon yet.



SG06 – the area in blue – has capacity for 3000 homes.<sup>1</sup> The SWLP needs to show how it will provide around 30,000.

## Why SG06 should be excluded from the Plan

The Plan has capacity for enough homes without building on green belt land.<sup>1</sup>

It is not lawful to build on green belt land if capacity can be met elsewhere.

SG06 is not a 'sustainable location'. It is a 30 minute walk to Leamington train station from the closest point and a one hour walk from the furthest.

The public footpaths are used and enjoyed by thousands of local residents and visitors.

The area provides habitat for wildlife and plant species including:

- v roe deer, muntjac deer, badgers, rural foxes
- birds on the RSPB's conservation 'red list' such as skylarks, swifts, fieldfares, house sparrows and starlings
- birds of prey such as sparrowhawks, peregrine falcons, kestrels and buzzards.
